Monthly Reports

- Finance Officer's Account with the Deputy Finance Officers to the Honorable Board of County Commissioners of Perkins County: I hereby submit the following report of my examination of the cash and cash items in the hand of the Deputy Finance Officers of this County as of March 31, 2022, Sylvia Chapman Finance Officer, Perkins County. The total amount represents state, county, schools, cities, and township funds to be transferred to various entities of government after being apportioned.

Highway Superintendent

- Highway Superintendent Green presented the Monthly Project & Maintenance Report for April. The crew was plagued with equipment breakdowns. Green would like to begin blading and ridge mulching next week. Load limits will expire April 28th.
- Green reported Matthew Butsavage resigned from the county effective March 25, 2022. Schweitzer moved, Campbell seconded to advertise for an operator position left open from Butsavage's resignation, motion carried.
- Campbell moved, Henderson seconded to approve the maintenance agreement with South Dakota Game, Fish & Parks off West Cabin Road and authorize Chairman Carmichael as signatory, motion carried.
- Schweitzer moved, Campbell seconded to authorize Chairman Carmichael as signatory on Work Order for Consultant Services with Brosz Engineering, for Bridge Inspection on Project P NBIS (42), PCN 04MG, motion carried.
- Henderson moved, Campbell seconded to authorize Chairman Carmichael as signatory on Amendment #716652 on BIG BRO 8053 (00) 18-1 PCN 06VC (Foster Bridge), motion carried.
- Discussion was held on rental tractor purchase. Schweitzer moved, Campbell seconded to authorize Superintendent Green to utilize the purchase option on the lease agreement with Deere Credit Inc on the 2019 John Deere 6135E ID #1P06135EJK0010992 and 2019 John Deere 6135EP ID #1P06135ECK0010993 for a total cost of \$80,918.14, motion carried.
- Green would like to purchase an 8.5-foot Road Groom for \$21,218 from Road Groom Manufacturing. Henderson moved, Campbell seconded to purchase a Road Groom for \$21,218 which includes the carbide teeth and hydraulic pump kit, motion carried.

Resolution 2022-07 Drought Resolution

Schweitzer moved, Campbell seconded to approve Resolution 2022-07 "Drought Disaster Resolution", roll call vote: Campbell aye, Schweitzer aye, Henderson aye, Carmichael aye, motion carried.

RESOLUTION 2022-07 **Drought Disaster Resolution**

WHEREAS, Perkins County is suffering from continuing severe drought conditions due to significantly low moisture, extreme heat, high winds, and wildland fire conditions that have increased to an extreme condition, and

WHEREAS, The Board of Perkins County Commissioners resolve that said conditions constitute a disaster of such severity and magnitude that effective response is beyond the capabilities of the County, or even the State of South Dakota, and that Federal assistance is necessary, and there are few emergency plans available to alleviate the damage and economic stress resulting from these drought conditions, to include the financial stress on the local volunteer fire departments in providing firefighting services; and

WHEREAS, Perkins County does not have the financial resources to respond to this disaster, and

WHEREAS, The Board of Perkins County Commissioners is aware of the sparse pastures and lack of forage crops for the feeding of livestock and wildlife, and because of this situation, conditions have arisen that may necessitate the reduction or dispersal of livestock herds and depletion of wildlife, and

WHEREAS, stock dams, creeks and other water sources are drying up and are unable to provide the necessary water for livestock, wildlife and fight fighting resources, and

WHEREAS, The Board of County Commissioners of Perkins County is aware that fall and spring planted agricultural crops are incurring drought damage,

WHEREAS, numerous other acres of South Dakota and surrounding states are also experiencing drought conditions which has threatened the availability of alternate sources of hay and forage,

WHEREAS, the farming, livestock, wildlife industry, and the local business community is important to Perkins County, the State of South Dakota, and the nation's economy, and should be preserved.

NOW, THEREFORE, BE IT RESOLVED, that Perkins County Board of Commissioners declares an emergency and a disaster and requests that the Governor of the State of South Dakota also declare an emergency and disaster for Perkins County, and

BE IT FURTHER RESOLVED, that the Board of Commissioner of Perkins County respectfully petition the Governor of the State of South Dakota and the President of the United States to provide with all dispatch any remedies and state and/or federal assistance, including assistance from the United States Department of Agriculture, available for this type of emergency.

Jens Hansen

Auto-supplement

Schweitzer moved, Campbell seconded to auto supplement 290-211-411 in the amount of \$100, from the American Rescue Plan allocation, motion carried.

APRA Funds

Henderson moved, Campbell seconded to elect the US Treasury Final Rule allowing counties to use up to \$10 million of the ARPA Recovery Funds as "loss revenue" for the provision of the general government services without needing to use the Treasury revenue loss formula, to use salaries and paid benefits for the Perkins County Employees as expense of the American Rescue Plan in addition to the other designated payments as budgeted in the 2020 ARPA fund (290) amount up to Perkins County's allocated amount of \$556,493.00 and to make the necessary transfers from the ARPA Fund to the appropriate funds, motion carried.
